5. Consider award of a contract for Road Reconstruction Projects in the Clinton Road, Tucholski Road, Mt. Zion Road, Skate Lane and Ohler Road areas of Bullskin Township. Tresco Paving Corporation of Pittsburgh, Pennsylvania submitted the lowest acceptable bid amount of \$231,077.00. There were a total of 6 bidders.
